2. The alignment proposed by that M/s Mars Endeavour Pvt. Ltd. Koregaon Park, Pune is across & laying of the section of Yedshi - Aurangabad on NH-52 is as follows:

- Laying of electric line of 18 nos of Pole to erection from km 186.770 to km 187.800.
- 01 no. of crossing at km 187.800 (Through HDD).

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
