**Sub:** 4-laning of Madhya Pradesh/Maharashtra Border Nagpur Section of NH-7 from Km.652.000 (New Km.653.225) to Km.729.000 including construction of Kamptee - Kanhan and Nagpur Bypass and Maintenance of already 4 -laned sections from Km.14.585.000 to Km.36.600 NH-7 (Nagpur-Hyderabad Section) in the State or Maharashtra under NHDP Phase-II on DBFOT Basis- Proposal for permission for laying of 33 KV 300 sqmm UG cable across the highway NH-44 (Nagpur-Chandrapur Highway) near Satgaon Fata under Tender T-02 (OH-UG) Scheme under Butibori divisional - Approval-Reg.
