Sub: NHAI-PIU-NSK-Six Laning of Pimpalgaon-Nashik-Gonde section of NH-3 from Km 380.000 to 440.000 in the State of Maharashtra- Proposal from Maharashtra State Electricity Distribution Company Ltd.'s (MSEDCL) for laying of 11 KV Underground Cable Line along NH-3 from Km. 425.600 to Km. 426.200, Km. 426.200 to Km. 428.300 & Km. 430.300 to Km. 431.500, Total length 3.900 km and 1 crossing at Km. 426.200 across NH-3- Reg.

Maharashtra State Electricity Distribution Company Ltd.'s (MSEDCL), Nashik Division, Nashik vide letter cited above has submitted Proposal for Laying & Crossing 11 KV Electrical Line along NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the laying of Electric Line is proposed along NHAI-ROW viz. Km. 425.600 to Km. 426.200, Km. 426.200 to Km. 428.300 & Km. 430.300 to Km. 431.500, Total length 3.900 km and 1 crossing at Km. 426.200 across NH-3.

As per Para-4 of Ministry of Road Transport & Highways (MoRTH) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
