Sub: NHAI, PIU, Puducherry – (N/08019/04001/TN) - Four laning of Sattanathapuram (Km.123/800) to Nagapattinam (Km.179/555) Section of NH-45A (New NH-32) on HAM under Bharatmala Pariyojana in the state of Tamil Nadu and UT Puducherry – Laying of 4" CS Pipeline along NH-45A between chainages from Km.181/650 to Km.186/500 for a total length of 4850m, crossing at Km.183/110 & Km.184/450, Construction of Steel valve chamber at Km.182/700, Km.184/400 & Km.186/500 and to lay 125mm MDPE pipeline parallelly along with 4" CS pipeline from Km.182/650 to Km.186/500 for a total length of 3850m and construction of MDPE valve chamber at Km.182/650, Km.183/500, Km.184/500, Km.185/500 & Km.186/300 in TR Pattinam to Vanjore – Invitation of Public Comments – Reg.

The subject proposal is requesting permission for laying of 4" CS Pipeline along NH-45A between chainages from Km.181/650 to Km.186/500 for a total length of 4850m, crossing at Km.183/110 & Km.184/450, Construction of Steel valve chamber at Km.182/700, Km.184/400 & Km.186/500 and to lay 125mm MDPE pipeline parallelly along with 4" CS pipeline from Km.182/650 to Km.186/500 for a total length of 3850m and construction of MDPE valve chamber at Km.182/650, Km.183/500, Km.184/500, Km.185/500 & Km.186/300 in TR Pattinam to Vanjore in the State of Tamil Nadu and UT of Puducherry by M/s. Torrent Gas Pvt. Ltd., in accordance with Ministry's latest guidelines Dt.22.11.2016.

2. M/s. Torrent Gas Pvt. Ltd has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a

reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.

3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. Torrent Gas Pvt. Ltd will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
