Sub: 6-laning from Panagarh to Palsit section of NH-19 (Old-NH-2) from Km 521.120 to Km 588.870 in the state of West Bengal under Bharatmala Pariyojana on BOT(Toll) Basis: Proposal for permission of crossing of 220 KV D/C Overhead Electrical Transmission Line of Damodar Valley Corporation in between Km 531.000 to Km 532.000 on NH-19 (Old NH-2)-reg.

The Project Director, PIU-Durgapur, NHAI vide letter no. 15017/1/2013/PIU(DUP)/DVC-531.00 to 532.00/8566 dated 13.12.2024 has submitted the subject mentioned proposal for granting licenses for use of National Highway land.

2. The proposal for laying 220KV D/C Over Head electrical Transmission line of Damodar Valley Corporation crossing of NH-19 (Old NH-2) is under:

Location (chainage)	Remarks
Km 531.00 to Km 532.000 (at crossing)	Damodar Valley Corporation, Durgapur has proposed to lay 220KV D/C Overhead Electrical Transmission line at the cited location. The tower's are placed outside RoW. Vertical clearance is as per CEA Safety Regulations, 2023 Gazette Notification Dt. 08.06.2023 (Schedule VIII A, Sec.4 part III).

- As per Ministry guideline issued vide no RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the Highway
 Administration shall make available the proposal for granting license for use of National Highway land for
 laying Utility service for public comments for 30 days on ground of public interest.
