INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-National Highway-744 in the state of Kerala- Accommodation of Public and Industrial Utility Service along National Highways-Laying underground cable through HDD method from Karicode Junction (Ch.6+100) to the pole marked as KK 105 near Supreme shopping center, Karicode (Ch.6+450) as part of RDSS scheme part 2-Reg.

1. The proposal is regarding permission sought by Kerala State Electricity Board Ltd. for laying of underground cable from Karicode Junction (Ch.6+100) to the pole marked as KK 105 near Supreme shopping center, Karicode (Ch.6+450) as part of RDSS scheme part 2 along NH-744 in the State of Kerala.
2. M/s KSEB Ltd. has furnished undertaking to shift the UG cable at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.
3. Further, M/s KSEB Ltd. has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, M/s KSEB. Ltd. has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed underground cable.
4. As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s KSEB Ltd. will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
