

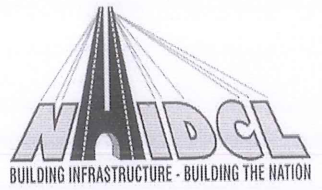

Sub: Construction of 220KV double Circuit transmission line from Kathalguri (NEEPCO) to Namsai (Powergrid): Submission of proposal of overhead crossing at NH-315 (Makum- Digboi Section at Ch. KM 5+900)- Reg.

The GM (P), PMU-Dibrugarh vide letter NHIDCL/PMU-DBRG/OH-Crossing/NH-315/Ch.5+900/2023/1649 dated 14.09.2024 has submitted a proposal along with recommendation for according 01 crossing permission across NH-315 for 220 KV Overhead Line Transmission line viz. AP 33/0 to AP 34/0 at chainage Km 5+900. The applicant, Power Grid Corporation of India Limited had submitted their proposal to the PMU vide their letter: NENMS/2023-24/TBCB/379 dated 11.01.2024. The GM(P), PMU-Dibrugarh has certified the proposals, checklist and drawings as per the extant practice.

2. The subject cited NH Section is being developed to a 2 Lane with paved shoulder facility at Chainage KM 5+900.

3. As per Ministry's circular no.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and subsequent modification dated 15.01.2021, the Highway administrator will make available the subject proposal on the portal for 30 days seeking for public comments on ground of public interest.
