



We are in receipt of the letter u/r (i) for grant of permission along and across NH-80 for execution of Raw Water transport system in Sahibgani District from DW&SD, Sahibgani.

- 2. This office vide letter no. 82 dated 23/04/2025 requested IE and concessionaire to inspect the site and submit the report. IE inspected the site and submitted its recommendation vide letter cited under reference (ii). Further concessionaire has also submitted its consent vide letter u/r (iv).
- The proposal has been examined by this office with respect to Ministry's 3. RW/NH-33044/29/2015/S&R/(R) dated 22.1.2016. 17.04.2023 36094/01/2022/S&R(P&B) dated & NH-36094/01/2022/S&R(P&B) (E-208825) dated 24.04.2023 and following is submitted:
- It is to mention that current proposal is regarding grant of permission for a. laying of water pipeline along and across NH-80 is in Sahibgani district in Rajmahal Area. The stretch of NH-80 where laying of water pipeline is proposed is greenfield at KM 239+880, which is under construction. .

- b. The laying of utility service across the NH will be done using HDD as per clause 3 of the MoRTH guideline dated 22.11.2016.
- c. The BG & License fee are calculated as per MoRTH guideline dated 17.04.2023 & 24.04.2023 and the same along with drawings are signed by PD.
- d. The checklist as per the circular signed by PD is also attached.
- e. Undertaking as per checklist sl. No. 41 & 44(i) is enclosed.
- f. Certificate from PD as per checklist sl. No. 49 & 54 is enclosed.
- g. The license fee is calculated along the proposed stretch as per the MoRTH guideline dated 17.04.2023 & 24.04.2023.
- 4. In view of the above, the proposal for laying of water pipeline along & across NH-80 is hereby recommended for your kind approval with following conditions:
 - i. The proper safety arrangement to be made during the construction to avoid in any untoward incident.
 - ii. The proper traffic management to be done during the construction.
- iii. This is to be ensured that at no time there is interference with the drainage of the road land and maintenance of the National Highways.
- iv. Any changes in license fee shall borne by licensee.
- v. The maintenance of Highway during and after construction including road restoration shall be done by DW&SD.
- vi. All the conditions mentioned as per MORTH guidelines circular dated 22.11.2016,17.04.2023 &24.04.2023 and its subsequent revision shall be binding to DW&SD.




