## Invitation of public comments

Subject:- Permission proposal for providing underground 150mm dia PVC Sewer pipeline & 50mm dia PVC water pipeline across the National Highways at Km 10/737 of NH-181(Coimbatore- Mettupalayam road) in the state of Tamil Nadu-Reg.

The proposal is regarding requesting permission for providing underground 150mm dia PVC Sewer pipeline & 50mm dia PVC water pipeline across the National Highways at Km 10/737 of NH-181(Coimbatore- Mettupalayam road) in Tamil Nadu state by M/s Akshaya Private Limited, G Square, Kandanchavadi, Chennai submitted to this office by the SE (NH), Salem vide letter No.1733/JDO-1/NH/2024 dated 10.06.2025. The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying underground 150mm dia PVC Sewer pipeline & 50mm dia PVC water pipeline is 32.20m. The carriageway width of stretch at Km.10/737 of NH 181 (Coimbatore-Mettupalayam road) is 20.00m. The Akshaya Private Limited, G Square, Kandanchavadi, Chennai has proposed to lay the underground HDD method across the road at Km.10/737 of the National Highway at a depth of 1.50m from the bottom of the road.

3. M/s Akshaya Private Limited, G Square, Kandanchavadi, Chennai has furnished an undertaking to the effect that they will remove the laid Industrial Utility Sewer pipe & water pipe line in future if required by NH Authority/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH Authority/MoRTH, Government of India and any right on the NH land. Further, mentioned that, Akshaya Private Limited, G Square, Kandanchavadi, Chennai will also restore the ROW surfaces to its original condition soon after removal of the Industrial utility Sewer pipe & water pipe lines. Also, certified that the proposed Industrial Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the application will be made available for public comments and
