INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala- Existing 2 lane section of NH-966 from Kozhikode to Palakkad (Km.15+656 to Km.140+960) in the State of Kerala-Accommodation of Public and Industrial Utility Service along National Highways-Laying of 3 Core 300 Sqm 11 KV UG Cable through HDD by KSEB from Chunnambuthara to Kalpathy bridge from Km.135+620 to Km.136+720(RHS) and crossing at Km.136+495 of NH-966-Reg.

The proposal is regarding permission sought by Kerala State Electricity Board for laying of 3 Core 300 Sqm 11 KV UG Cable through HDD by KSEB from Chunnambuthara to Kalpathy bridge from Km.135+620 to Km.136+720(RHS) and crossing at Km.136+495 of NH-966 along the subject project stretch in the State of Kerala.

2. KSEB has furnished undertaking to shift the UG cable at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular. No. RW/NH-33044/29/2015-S&R dated 22.11.2016.

3. Further, KSEB has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, KSEB has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed UG Cable.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Kerala State Electricity Board will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
