Subject- Proposal of M/s Gujarat Gas Limited for permission for laying 125 mm dia PE Natural Gas pipeline to connect proposed CNG station namely Rajrishi petroleum near existing Bharat Petrol Pump in parallel to NH-47 from km 100/00 to km 98/500 in RHS along the pipeline route in taluka -Limbadi, Dist Surendranagar in the State of Gujarat-Reg.

The Roads and Building Department, Government of Gujarat vide letter no. NHP-13-2023-655-M dated 11/10/2023 has recommended the subject cited proposal for laying 125 mm dia PE Natural Gas pipeline to connect proposed CNG station namely Rajrishi petroleum near existing Bharat Petrol Pump in parallel to NH-47 from km 100/00 to km 98/500 in RHS along the pipeline route in taluka -Limbadi, Dist Surendranagar in the State of Gujarat for approval of Highway Administration cum RO, Gandhinagar.
