Sub: NHAI - PIU, Villupuram - Two laning with Paved Shoulder of Meensuruti (Km.98.433) to Chidambaram (Km.129.965) Section of NH-81 - Proposal seeking NOC & Permission for laying of Water Pipe Line along the road from Km.108/750 to Km. 129/940 (RHS) of NH-81(Old NH-227) (Meensurutti to Chidambaram Section) by M/s. TWAD Board, Cuddalore - Approval requested - Reg.

1. The subject proposal is requesting permission for laying of Water Pipe Line of 700mm dia GI K7 Pipe along the road from Km.108/750 to Km. 129/940 (RHS) for total length of 21190m in the project stretch of NH-81 (Meensurutti to Chidambaram Section) in the State of Tamil Nadu.
2. M/s. TWAD Board, Cuddalore has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. TWAD Board, Cuddalore will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
