Invitation of Public Comments

Sub: Request for grant of right of way permission for laying/crossing of optical fiber cable (OFC) on NH-31 from Km 53.940 to Km 54.600 (LHS), from Km 54.600 to Km 56.4000 (RHS), from Km 59.100 to Km 62.700 (LHS) & Crossing at Km 54.600, total Route length 6.060 Km in Uttar Pradesh.

The office of the Bharti Airtel Limited has submitted the proposal for permission for laying/crossing of optical fiber cable (OFC) on NH-31 from Km 53.940 to Km 54.600 (LHS), from Km 54.600 to Km 56.4000 (RHS), from Km 59.100 to Km 62.700 (LHS) & Crossing at Km 54.600, total Route length 6.060 Km in Uttar Pradesh

From the submitted proposal, it is seen that the laying/crossing length is proposed to 6.060 Km for the aforesaid subject work. Width of available ROW in LHS & RHS side is 28.25 m to 28.25m (Variable) from center of NH-31. The exiting NH is 4-lane with divided carriageway.

As per the guidelines, issued by the Mort&h No. RW/NH-33044/29/2015/S&R (R) (dtd. 22.11.2016. The application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interests).

In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained.
