Sub:- Proposal for permission for laying underground water supply pipe line from Km 119.555 to Km 120.140 (585m) LHS, Km 130.680 to Km 131.380 (700m) LHS & crossing by HDD method at Km 120.140 & Km 131.380 on NH-09 (Delhi-Moradabad Section) at District-Amroha in the State of Uttar Pradesh.

The Executive Engineer, UP Jal Nigam (Grameen), Amroha has submitted the Proposal for permission for laying underground water supply pipe line from Km 119.555 to Km 120.140 (585m) LHS, Km 130.680 to Km 131.380 (700m) LHS & crossing by HDD method at Km 120.140 & Km 131.380 on NH-09 (Delhi-Moradabad Section) at District-Amroha in the State of Uttar Pradesh.

2. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest). In this regard, RO-UP(West), NHAI, Lucknow vide letter no. 19001/1/RO-W-UP/Utility/19471 dated 21.03.2023 has also issued directions to put out the application of Public and Industrial Utility Services along and across National Highway in the public domain for 30-days for seeking public comments at PIU Level.

3. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained.
