Invitation of Public Comments

Sub: NHAI - PIU, Salem - Proposal for Laying of underground Sewerage pipes along NH-44 from Km 201/980 to Km 203/120 (RHS) and Km 202/130 to Km 203/090 (LHS) for a total length of 2100m (1140m +960m) in the limit of Salem District by the Commissioner, Salem City Municipal Corporation Salem - Approval requested - Reg

- 1). The subject proposal is requesting permission for laying of 600mm Dia underground Sewerage system along the NH-44 by Trench Method from Km 201/980 to Km 203/120 (RHS) and Km 202/130 to Km 203/090 (LHS) in the project of Thumbipadi to Namakkal section of NH-44 in the State of Tamil Nadu
- 2). The Commissioner, Salem City Municipal Corporation Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Commissioner, Salem City Municipal Corporation Salem will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
