Km 6.250 (ISBT) (Length: 6250m) and Crossing at 0.710 Km (Length: 14m), 3.200Km (Length: 17m) & 3.920Km (Length: 17m) of NH-37 Village/ Mouza: Silchar Town, Pargona: Barakpar to Village/ Mouza: Tarapur Pt IV, Pargona: Barakpar Circle: Silchar Sadar in Cachar District in the state of Assam: **Reg.**

The GM(P), PMU-Silchar vide letter no. PMU-Silchar/U/OFC/2025-26/5523 dated 31.05.2024 has submitted a proposal along with recommendation to obtain permission for laying of 6" Dia CS, 4"dia CS, 125mm Dia (MDPE) & 90mm Dia (MDPE) Gas Pipeline along & across at NH-37 from Ch. 0.000 (Sadarghat) to Ch. Km 6.250 (ISBT) (Length: 6250m) and Crossing at 0.710 Km (Length: 14m), 3.200 Km (Length: 17m) & 3.920Km (Length: 17m) by Horizontal Directional Drilling. The applicant, Purba Bharati Gas Private Limited (PBGPL) had submitted their proposal to the PMU vide their letter no. PBGPL/GA9.02/NHIDCL/32 dated 26.12.2024. The GM(P), PMU-Silchar has certified the proposal, checklist and drawings as per the extant practice.

2. The subject cited NH Section is being bypassed by the Silchar- Churaibari Pkg-1 Project and there will be no further expansion of the section from the present 2 Lane profile.

3. As per Ministry's circular no.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and subsequent modifications dated 17.04.2023 and 24.04.2023, the Highway administrator will make available the subject proposal on the portal for 30 days seeking for public comments on ground of public interest.
