Invitation of Public Comments


Sub: NHAI - PIU, Salem - Proposal for laying of a Public Utility - "City Gas Distribution (CGD): Carbon Steel and MDPE Pipelines with OFC across the NH-44 @ Km 197/480, Km 198/500, 198/588, 201/070 & Km 204/671 by HDD Method in the limit of NH, Salem by M/s Indian Oil Corporation Limited, Salem - Approval requested - Reg

- 1). The subject proposal is requesting permission for laying of underground 4.5" Dia Carbon Steel and MDPE Pipelines with Optical Fiber Cable (OFC) across the NH-44 @ Km 197/480, Km 198/500, 198/588, 201/070 & Km 204/671 by HDD in the project of Thumbipadi - Namakkal section of NH-44 in the State of Tamil Nadu.
- 2). M/s Indian Oil Corporation Limited, Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s Indian Oil Corporation Limited, Chennai will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.


