Sub: NHAI – PIU, Salem – Proposal for laying proposed 4' dia steel & 125 mm dia MDPE Gas pipeline of NH-44 (Thumbipadi – Namakkal) along the road from Km 222/289 to Km 234/434 (LHS) and Km 234/434 to Km 235/486 and across @ Km 222/289, Km 234/434 & Km 233/415 and Valve Chambers @ Km 222/969 (LHS), Km 223/969 (LHS), Km 224/969 (LHS), Km 225/969 (LHS), Km 226/969 (LHS), Km 227/969 (LHS), Km 228/969 (LHS), Km 229/969 (LHS), Km 230/969 (LHS), Km 231/969 (LHS), Km 232/969 (LHS), Km 233/969 (LHS) & Km 234/969 (RHS) for the total length of 13377m from Thengalpalayam Bus stop to RGR CBSE International School connectivity to develop City Gas Distribution Network in Rasipuram & Namakkal Taluk of District Namakkal, State of Tamilnadu by M/s IRM Energy Limited, Ahmedabad - Approval requested - Reg

The subject proposal is requesting permission for laying proposed 4' dia steel & 125 mm dia MDPE Gas pipeline of NH-44 along the road from Km 222/289 to Km 234/434 (LHS) and Km 234/434 to Km 235/486 and across @ Km 222/289, Km 234/434 & Km 233/415 and Valve Chambers @ Km 222/969 (LHS), Km 223/969 (LHS), Km 224/969 (LHS), Km 225/969 (LHS), Km 226/969 (LHS), Km 227/969 (LHS), Km 228/969 (LHS), Km 229/969 (LHS), Km 230/969 (LHS), Km 231/969 (LHS), Km 232/969 (LHS), Km 233/969 (LHS) & Km 234/969 (RHS) for the total length of 13377m from Thengalpalayam Bus stop to RGR CBSE International School connectivity to develop City Gas Distribution Network in Rasipuram & Namakkal Taluk of District Namakkal, State of Tamilnadu in the project of Thumbipadi to Namakkal section of NH-44 in the State of Tamil Nadu

M/s IRM Energy Limited, Ahmedabad has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.

As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s IRM Energy Limited, Ahmedabad will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
