Indian Oil Corporation Limited., Chennai letter No. SRPL/MAN/ML/1001/02 dated 03.12.2021 (2 nos.)

2. The details of proposal are as under:

- b. The available width of ROW from 45.0 m in TPP Road and 60.0 m in MORR from existing centre line.
