The proposal is regarding for laying of underground Gas Pipeline along the road from Km 19/710 to Km 22/000 and Km 22/400 to Km 23/350 on RHS by Open Trench Method and Km 22/000 to Km 22/400 on RHS by HDD Method and across the road at two locations at Km 19/710 and Km 23/350 by HDD Method submitted to this office by M/s. Torrent Gas Chennai Private Limited., Chennai letter dated 08.02.2022.

2. The details of proposal are as under:

a. The above proposal pertains to the laying of underground Gas Pipeline along the road from Km 19/710 to Km 22/000 and Km 22/400 to Km 23/350 on RHS by Open Trench Method and Km 22/000 to Km 22/400 on RHS by HDD Method and across the road at two locations at Km 19/710 and Km 23/350 by HDD Method.

b. The available width of ROW from 60.0 m in IRR from existing centre line.

3. M/s. Torrent Gas Chennai Private Limited., Chennai has furnished an undertaking to accept any claims raised by the Contractor/Concessionaire if any and the same will be paid by them and furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.


