Mayampillayar Naturals Private Limited, Namakkal - Approval requested - Reg

- 1). The subject proposal is requesting permission to erect a 22-KV Over Head Electrical Transmission H-T Line AI-59 Panther Conductor Power Cables line and 120m C/C interval H-T Towers along the RoW from Km 238/120 to Km 242/330 on the LHS and across the road H-T line with Tower Crossing at Km 238/120 from RHS to LHS on the NH-44 (Old NH-7) (Bangalore - Madurai Section) in the State of Tamil Nadu.
- 2). M/s. Mayampillayar Naturals Private Limited, Namakkal has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, SPD, Perundurai will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
