Sub: NHAI - PIU, Salem - Permission to Erection of 22 KV Overhead Electrical Power Transmission Line & Poles from Km 242/917 to Km 245/084 along LHS in Thumbipadi - Namakkal Section of NH-44 (Old NH-7) in the state of Tamilnadu by M/s Thenpandian Spinning Mills India Pvt Ltd, Namakkal - Approval requested - Reg

- 1). The subject proposal is requesting permission to erect 33 KV Overhead Electrical Power Transmission Line & Poles from Km 242/917 to Km 245/084 along LHS in Thumbipadi - Namakkal Section of NH-44 (Old NH-7) in the state of Tamilnadu.
- 2). M/s Thenpandian Spinning Mills India Pvt Ltd, Namakkal has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
