(b). The Bidder shall deposit a BID Security of Rs. 71,93,000.00 (Rupees seventy one lacs ninety three thousand only) in accordance with the provisions of this RFP. The Bidder has to provide the BID Security in the form of a Bank Guarantee acceptable to the Authority, as per format at Appendix-II. The bidders shall also submit Demand Draft for Rs. 10,000.00 issued from a scheduled Bank in favour of [Executive Engineer, N.H. Division, Chapra] payable at [Chapra].

The validity period of the Bank Guarantee, shall not be less than 180 (one hundred and eighty) days from the BID Due Date, inclusive of a claim period of 60 (Sixty) days, and may be extended as may be mutually agreed between the Authority and the Bidder. The BID shall be summarily rejected if it is not accompanied by the BID Security. The BID Security shall be refundable no later than 150 (one hundred and fifty) days from the BID Due Date except in the case of the Selected Bidder whose BID Security shall be retained till it has provided a Performance Security under the Agreement.

For participating in the above E-RFQ & RFP process, the contractors shall have to obtain user ID, password and digital signature may be issued to them. This will enable them to access the official portal of [https://eprocure.gov.in] and download/ participate in E-EPC tender.
