It is to inform all concern that MIDC Aurangabad vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Aurangabad has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that MIDC Aurangabad along on Aurangabad-Paithan Section of NH-752 in the State of Maharashtra is as follows:

- Underground Raw Water line laying from Design km. 45+500 to km. 46+000(450m) in utility corridor & crossing 01 nos. At ch.46+000 in Aurangabad to Paithan section of NH-752 E.
- Laying water line at edge of ROW, in utility corridor from Design km 45/500 to km 46/000 by Open trenching method and Crossing at ch. 46/000 with carried out by HDD/Push Through Method.
- Water line to be laid in Duct 1.2m below ground level in both method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch. The objections / comments may be addressed to the below mentioned address upto 16.01.2021, beyond due date, no comments/ objections will be accepted.
