Project Director, NHAI, PIU-Ranchi vide letter no. 1753 dated 10.12.2025 & 1799 dated 12.12.2025 has submitted the proposal of "M/s JUSNL regarding O/H EHT line crossing of 132KV Baharagora-Dhalbhumgarh LILO-1 (AP-1C to AP-1D) at Ch. Km.310+61m, Chakulia & 132KV Baharagora-Dhalbhumgarh LILO-2 (AP-1F to AP-1G) at Ch. Km.310+607m, Chakulia in the district of East Singhbhum", in the state of Jharkhand for approval of Competent Authority.
