The permission for laying of Gas Pipe Line shall be considered for approval / rejection based on the Ministry Circulars mentioned as above,

Carrying of sewage/gas pipelines on highway Bridges shall not be permitted as Furmes/gases pipes can accelerate the process of corrosion or may cause explosions, thus, being much more injurious than leakage of water.

Services are not being allowed indiscriminately on the parapet/any part of the bridges, Safety of the bridges has to be kept in view while permitting various services along bridge.

<u>Conditions for the agencies seeking permission for laying Gas Pipeline across</u> the National Highway that are under NHAI

- 1. Any damage during the laying of pipeline to existing service lines (Gas pipeline, water supply line, electric line or any other line) should be got repaired immediately at the agency's own risk and cost.
- 2. Necessary precaution should be taken to avoid accident during construction work.
- 3. Cautionary board where required should be kept on site before starting the work of laying pipes.
- 4. Prior approval of department shall be obtained before undertaking the work of installation, shifting, repairs or alternating to the utility line located in the NHAI's right of way.
- 5. Before starting the work, prior written information by Registered Post AD should be given to Project Director, NHAI PIU, Udaipur, Rajasthan.
- 6. If NHAI considers it necessary in the future to remove the pipeline for any work of improvement / repairs of road, it will be carried out as desired by NHAI at the cost of agency within a reasonable time.
- 7. NHAI does not guarantee the preservation of agency's property from any type of damage that may occur due to road work carried out at a later date.
- 8. If any accident is occurs during the execution or completion of work by the agency, the complete responsibility shall be fully on the head of agency.
- 9. In future, at the time of widening the road or any other work of NHAI, the line shall have to be removed / shifted by the agency at their own cost without claim of compensation within 60 days.
- 10. A security deposit of Rs. 100/- per mtr, BG should be paid before start of work.
- 11. An agreement on stamp paper of Rs. 300/- is required to be made between NHAI and agency before start of work. This shall also include No Claim Certificate.
