It is to inform all concern that M/s GAIL (India) Limited vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU-1, Nagpur has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s GAIL (India) Ltd. is along Outer Ring Road Pkg-I of Nagpur city in the State of Maharashtra is as follows:

Laying of Gas pipeline 18" dia Natural Gas Pipeline along with 40mm OFC parallel to Outer Ring Road, Pkg-I from km 0.500 to 6.060 through HDD Method.

- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
