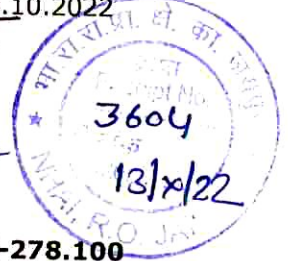

2. The said proposal has been examined by Team Leader of the Project Jaipur Jaipur Kishangarh section of NH-8, IE M/s. Feedback Infra Pvt. Ltd. in association with ARMENGE Engineering and Management Consultants Pvt. Ltd. IE vide their letter dated 08.08.2022 (**Annex-2**) has recommended for laying underground Electric Cable from MS-278.100 to MS-281.000 LHS side of NH-8 total length is 2.900 km ROW applied in the State of Rajasthan.

3. Further, IE vide their letter dated 08.08.2022 has submitted comments as under :-

1. Electric cable shall be laid only by HDD method. Applicant may be advised to follow the undertaking submitted by him strictly.
2. No open excavation within RoW may be permitted. All roads, buildings, structures etc. should be crossed by HDD only and pits may be dugged outside the Right of Way.
3. Bituminous Pavement / Paved areas etc. shall not be excavated / damaged during the laying work of electric cable.
4. No damage shall be done to Avenue Plantation, Electrical Cables, Project OFC, OFCs of other parties, electrical lines etc. during execution of the work. The applicant shall be responsible solely for such damages. Applicant shall make good the damages caused to aforesaid services at its own cost.

5. Adequate caution money may be kept as security deposit for rectification of defective works at the Risk and Cost of Agency, if the agency does not take up the works.
6. The applicant shall adopt adequate safety measures to avoid accidents / mis-happenings during execution of work. The applicant may be made solely responsible for such accidents / mis-happenings, if any, on account of its failure to take safety measures as may be necessary to avoid such mis-happenings.
7. HDD / laying of electric cable works shall be carried out only during the day time. No work may be permitted to be carried out after sunset.
8. As-built drawings of the completed work shall be submitted to NHAI/Concessionaire for further reference at the completion of work.
9. Applicant may be asked to submit the as-built drawings after completion work.

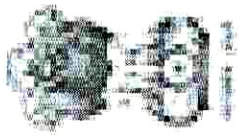

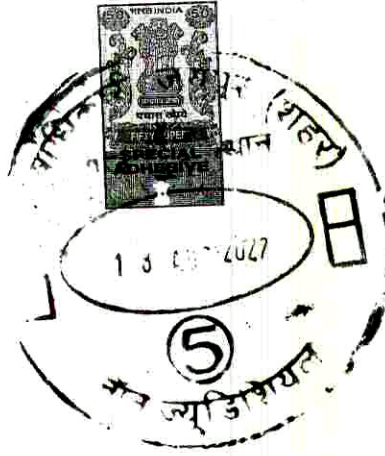

4. No damage shall be done to Avenue Plantation, Electrical Cables, Project OFC, OFCs of other parties, electrical lines etc. during execution of the work. The applicant shall be responsible solely for such damages. Applicant shall make good the damages caused to aforesaid services at its own cost.
5. Adequate caution money may be kept as security deposit for rectification of defective works at the Risk and Cost of Agency, if the agency does not take up the works.
6. The applicant shall adopt adequate safety measures to avoid accidents / mis-happenings during execution of work. The applicant may be made solely responsible for such accidents / mis-happenings, if any, on account of its failure to take safety measures as may be necessary to avoid such mis-happenings.
