Invitation of public comments

Subject:- Permission Proposal for laying of 24" Dia R-LNG pipeline along with underground Optical Cable the NH across Perambalur -Ariyalur - section at Chainage Km 4/925 of NH-226Extn of Eraiyur Village Perambalur Taluk and Perambalur District in the State of Tamil Nadu-Reg.

The proposal is regarding permission for laying of 24" Dia R-LNG pipeline along with underground Optical Cable the NH across Perambalur -Ariyalur - section at Chainage Km 4/925 of NH-226Extn of Eraiyur Village Perambalur Taluk and Perambalur District in the State of Tamil Nadu was submitted to this office by the SE, NH Madurai vide letter No.1765/NH/AE-II/2019 dated 12.12.2019 (received on 16.12.2019) has submitted the proposal to this office in accordance with Ministry's latest guidelines dated 22.11.2016.

2. The alignment proposed by M/s IOCL, laying of 24" Dia R-LNG pipeline along with underground Optical the National Highways across Perambalur -Ariyalur - section at Chainage Km 4/925 of NH- 226Extn as detailed under:

3 The right of way 40.00m in the aforesaid stretch. The carriageway width of aforesaid stretch is 7.00 m. SE,NH- Madurai has stated that M/s IOCL has laying of 24" Dia R-LNG pipeline along with underground Optical Cable at the edge of the ROW. R-LNG pipeline along with underground Optical Cable across NH-226Extn at Chainage Km 4/925 is proposed to lay by HDD method at a depth of 7.00m from the bottom of the road.

4. M/s IOCL, for laying of 24" Dia R-LNG pipeline along with underground Optical Cable the NH across at Chainage Km 4/925 of NH- 226Extn has furnished an undertaking to the effect that M/s IOCL,for laying of 24" Dia R-LNG pipeline along with underground Optical Cable the NH across at Chainage Km 4/925 of NH- 226Extn will remove the laid OFC line in future if required by NH wing of State Highways Department/MoRTH Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH Govt. of India and any right on the NH

land. Further, mentioned that M/s IOCL for laying of 24" Dia R-LNG pipeline along with underground Optical Cable the NH across at Chainage Km 4/925 of NH-226Extn, will also restore the surfaces to its original condition soon after removal of the OFC lines. Also, certified that the proposed Optical fiber cable work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5 As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
