Laying of Gas pipeline 18" dia Natural Gas Pipeline along with 40mm OFC parallel to NH-44 from km 747+510 to 717+050 & 8 Nos Crossings through HDD Method.

- As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
