Sub: Request for granting of permission for laying of Mild Steel Water supply pipeline along / across NH-752-E (Aurangabad - Paithan Road) between km 0+000 to km 45+000 of District Aurangabad- Reg.

It is to inform all concern that MJP Division, Aurangabad vide letter under reference (2) has submitted a proposal for the subjected work and PD, NHAI, PIU, Aurangabad has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.


2. The alignment proposed by that MJP Division, Aurangabad along on Aurangabad-Paithan Section of NH-752-E in the State of Maharashtra is as follows:

- Laying of (2500mm dia. M.S. Pipe) pipeline along Highway (RHS) from Ch. 14+000 to km 38+450 at the extreme edge of RoW using open trench method at 1.2m below ground level.
- Crossing at Ch. 2+450 and at Ch. 14+000 through HDD method.
- Laying of pipeline along highway (LHS) from Ch. 2+450 to 14+000 (2500mm dia MS pipe) extreme edge of RoW using open trench method at 1.2m below ground level.
- Laying of pipeline along highway (LHS) from Ch. 0+000 to Ch. 2+450 (1100mm dia MS pipe) at extreme edge of ROW using open trench method at 1.2m below ground level.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch. The objections / comments may be addressed to the below mentioned address within 30 days from issuance of public comments, beyond due date, no comments/ objections will be accepted.
