## INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala- Six laning of Kottukulangara to Start of Kollam bypass Section of NH-66 (from Design Ch. 454+500 to Design Ch. 486+000) on HAM under Bharatmala Pariyojna - Proposal for laying of 11 KV UG cable from Karungappally Sub Station to Kalloorumukku under Electrical Section, Ochira in Dyuthi Scheme (Km 468+100 to Km 464+315 on RHS)-Reg.

- 1. The proposal is regarding permission sought by KSEB for laying of underground cable from Karungappally Sub Station to Kalloorumukku under Electrical Section, Ochira in Dyuthi Scheme (Km 468+100 to Km 464+315 (RHS) on NH-66 in the State of Kerala.
- 2. KSEB has furnished undertaking to shift the UG cable at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH33044/29/2015-S&R dated 22.11.2016.
- 3. Further, KSEB has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, KSEB has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed underground cable.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by KSEB will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
