INVITATION OF PUBLIC COMMENTS

Subject: NHAI, Madurai Region - Highway Administration - laying of Water supply pipeline under PIU, Karaikudi - Permission for laying Water supply pipeline by TWAD Board, Sivagangai along highway from Km 95/900 to Km 98/200 Thanjavur - Manamadurai section of NH 226 - Invitation of Public Comments - Reg.

The Proposal is regarding permission for laying of water supply pipeline from Km 95/900 to Km 98/200 RHS and across the road at Km.95/900 LHS on Thanjavur - Manamadurai section of NH 226 TWAD Board, Sivagangai.

2) TWAD Board, Sivagangai has proposed to lay the Water supply pipeline for a length of 2330 m along the edge of the ROW, which is at a distance of 15m from centerline of the project and across the project at 01 location at a depth of 1.5m below ground level. The proposal is in conformity with Ministry's guidelines vide letter No. NHIII/P/66/76 dated 19.11.1976.

3) Further TWAD Board, Sivagangai has mentioned that the Water supply pipeline along the NH by Open Trench Method at a depth of 1.16m for along portion and by HDD at a depth of 1.5m for across portion.

4) TWAD Board, Sivagangai has furnished an undertaking to the effect that the applicant will remove the laid Water supply pipeline in future if required by NHAI/MoRTH, Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation. Further, mentioned that TWAD Board, Sivagangai will also restore the surfaces to its original condition soon after removal of the Water supply pipelines.

5) As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/S&R(R) dated 22.11.2016 the proposal submitted by the applicant will be made available for public comments and the comments is invited within 30 days from the day of uploading.
