

With reference to the above subject, I would like to bring to your kind notice that 11 kv underground (UG) cable laying is proposed to strengthen and improve the power supply system in Rayagada Municipality area. The new 11 kv UG line cannot be laid through overhead means due to site constraints; hence, underground laying is planned across Tumbiguda junction.

The following details are submitted for consideration during the UG cable crossing:

- Location: From Balaji Sweets to SBI SME Branch
- Length of road to be crossed: 25 meters
- Chainage: 200.100
- Method of UG cable laying: HDD (Horizontal Directional Drilling) method
- Depth of cable laying: 3 meters (10 feet)
- GPS Coordinates:
 - Balaji Sweets – 19.187139, 83.415524
 - SBI SME Branch – 19.187174, 83.415659
- Safety Measures: Cable will be laid through HDPE pipe. After completion, route markers will be installed indicating cable specifications and depth of laying.

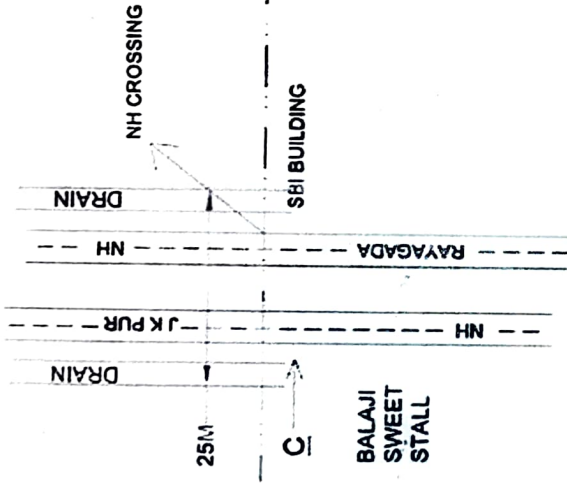
