Sub: Improvement, Operations & Maintenance including Strengthening & Widening of existing 2 lane roads to 4 lane dual carriageway from km 9.200 to km 50.000 section of NH-6 (Nagpur-Kondhali) in State of Maharashtra on BoT basis -**Proposal for grant of Permission for laying water supply line along National Highway from km 21.400 to km 13.300 (LHS) & from 32.000 to km 34.700 (RHS) and crossing at km 21.400 & km 34.700 Warddhamna to Nagalwadi - Reg.**

It is to inform all concern that Executive Engineer, MJP, Nagpur vide letter under reference (ii) has submitted a proposal for the subjected work and PD, has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that MJP, Nagpur along on Nagpur- Kondhali Section of NH-53 (Old NH-06) in the State of Maharashtra is as follows:

- Laying of (250mm dia. DI Pipe) pipeline along Highway from km 21.400 to km 13.300 (LHS) & from 32.000 to km 34.700 (RHS) at the extreme edge of RoW using open trench method at 1.2m below ground level.
- Crossing at Ch. 21.400 & Ch. 34.700 through HDD method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch. The objections / comments may be addressed to the below mentioned address within 30 days from issuance of public comments, beyond due date, no comments/ objections will be accepted.
