It is to inform all concern that the M/s. IGL, New Delhi vide letter under reference (1) has submitted a proposal for the subjected work and PD, NHAI, PIU, Jaipur has submitted the above proposal vide letter under reference (2) for approval of the Competent Authority, Highway Administration.

- 2. The proposal is regarding permission for laying of Gas Pipeline of M/s. Indraprastha Gas Ltd. (IGL) (125mm dia MDPE Pipe) from Km. 86.475 to 91.530 (LHS) (length 5055m) and three nos. crossing at Km. 89.165 (length 77.10m), Km. 90.975 (length 62.10m) & Km. 91.530 (length 62.10m) and 110m length extra from Bus-bay and entry/exit (Total length 5366.30m) along NH-8 (New NH-48), Delhi-Jaipur Road in the state of Haryana.
- 3. As per Para-4 of Ministry's Circular No. RW/NH-33044/29/2015S&R(R) dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, before approval of the competent authority, the comments/objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11 .2016 due to laying of Gas Pipeline along and across on the subjected stretch. Please refer M/s Idraprastha Gas Limited, Rewari above referred letter dated 05.02.2021 regarding NOC for laying of Gas Pipe line of "M/s Indraprastha Gas Limited (IGL) (125mm Dia MDPE Pipe) from Km 86.475 LHS to Km 91.530 LHS (length 5055m), Three crossing at Km 89.165 (length 77.10m), Km 90.975 (length 62.10m) & Km 91.530 (length 62.10m) and 110m length Extra from Bus-Bay and Entry/Exit (total length 5366.30m) along NH-8 (new NH-48) Delhi to Jaipur Road) in the State of Haryana.

2. The said proposal has been examined by Independent Engineer of the Project Gurgaon-Kotputli-Jaipur section of NH-8, M/s. URS Scott Wilson India Pvt Ltd. IE vide their letter dated 23.04.2021 has recommended for according in approval for the said proposal to this office for laying of Gas Pipe line of "M/s Indraprastha Gas Limited (IGL) (125mm Dia MDPE Pipe) from Km 86.475 LHS to Km 91.530 LHS (length 5055m), Three crossing at Km 89.165 (length 77.10m), Km 90.975 (length 62.10m) & Km 91.530 (length 62.10m) and 110m length Extra from Bus-Bay and Entry/Exit (total length 5366.30m) along NH-8 (new NH-48) Delhi to Jaipur Road) in the State of Haryanaa. Independent Engineer of the Gurgaon-Kotputli-Jaipur project vide letter dated 23.04.2021 has submitted the following:

"The IE's representative has inspected the proposed site on 12.04.2021 for Laying of Gas Pipe Line of "M/s Indraprastha Gas Limited (IGL)" (125mm Dia MDPE Pipe) from Km. 86.475 LHS to Km. 91.530 LHS (Length 5055m), Three crossing at Km. 89.165 (Length 77.10m), Km. 90.975 (Length 62.10m) & Km. 91.530 (Length 62.10m) and 110m Length Extra from Bus- Bay and Entry/Exit (Total Length 5366.30m) along NH- 8 (New NH- 48) (Delhi to Jaipur Road) in the State of Haryana along with their Consultants (Empanelled by MoRTH) and our comments are given below.

In this regard, NHAI has requested to examine the checklist, drawings & other documents of the proposal in the accordance with MoRTH/NHAI guidelines & as per site condition & submit the

In accordance with sub clause 43.1 of CA, the Concessionaire shall have right to the use of the site as sole licensee subject to and in accordance with the Concession Agreement, and to this end, it may regulate the entry and use of the Project Highways by third parties in accordance with and subject to the provisions of CA.

In view of the above, the Concessionaire was requested vide 1st cited to go through the contents of said proposal for premission for Laying of Gas Pipe Line of "M/s Indraprastha Gas Limited (IGL)" (125mm Dia MDPE Pipe) from Km. 86.475 LHS to Km. 91.530 LHS (Length 5055m), Three crossing at Km. 89.165 (Length 77.10m), Km. 90.975 (Length 62.10m) & Km. 91.530 (Length 62.10m) and 110m Length Extra from Bus- Bay and Entry/Exit (Total Length 5366.30m) along NH- 8 (New NH- 48) (Delhi to Jaipur Road) in the State of Haryana and submit your comments / inspection report with respect to Ministry of Road Transport & Highways Circular no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 & Ministry letter no. RW/JAI/RJ/PS/2017/UTILITY/GENL/1161-1189 dated 16.03.2017 within three days along with the copy of the proposal for our review and comments.

It has also requested that comments on this matter shall clearly mention that whether the location of the proposed gas pipeline is in urban/rural area and other points which are not covered in Ministry Checklist but are necessary having regard to road safety.

The Concessionaire's Consent/no objection for the said proposal has not been received till date from the date of IE's letter no. 197 dated 01.04.2021 to Concessionaire under reference 1st cited. As more than 20 days have elapsed since our request to the Concessionaire, it is informed that the consent of the Concessionaire is deemed to have been received for this case and it is also presumed that there is no objection from the Concessionaire.

However, we had gone through the contents of said proposal and examined the checklist, drawings & other documents of the proposal as per site condition. Our comments on this proposal are also given below.

Upon examination of the submitted documents, it has been noted that the applicant has submitted the checklist, drawings & other documents in accordance with Ministry's Guidelines issued vide letter no. RW/NH-33044/29/2015/ S&R (R) dated 22.11.2016 & Ministry letter no. RW/JAI/RJ/PS/2017/UTILITY/GENL/1161-1189 dated 16.03.2017.

Upon examination of the drawings, it has been noticed that, the applicant has proposed the gas pipeline from Km. 86.475 LHS to Km. 91.530 LHS (Length 5055m), Three crossing at Km. 89.165 (Length 77.10m), Km. 90.975 (Length 62.10m) & Km. 91.530 (Length 62.10m) and 110m Length Extra from Bus- Bay and Entry/Exit (Total Length 5366.30m) along NH- 8 (New NH- 48) (Delhi to Jaipur Road).

Our representative has inspected the site along with M/s IGL representative to check the physical availability of utility corridor at the desired stretch of project highway for the proposed laying of gas pipeline, it has been observed that, the proposed gas pipeline has passing from Km. 86.475 LHS to Km. 91.530 LHS (Length 5055m), Three crossing at Km. 89.165 (Length 77.10m), Km. 90.975 (Length 62.10m) & Km. 91.530 (Length 62.10m) and 110m Length Extra from Bus- Bay and Entry/Exit (Total Length 5366.30m) along NH- 8 (New NH-48) (Delhi to Jaipur Road). Therefore, the above said proposal has been considered from Km. 86.475 LHS to Km. 91.530 LHS (Length 5055m), Three crossing at Km. 89.165 (Length 77.10m),

Km. 90.975 (Length 62.10m) & Km. 91.530 (Length 62.10m) and 110m Length Extra from Bus-Bay and Entry/Exit (Total Length 5366.30m) along NH-8 (New NH-48) (Delhi to Jaipur Road) for granting the permission under the jurisdiction of NHAI PIU Jaipur. Accordingly, the corrected drawings & checklist has been received from the applicant.

Further, it has also been observed that some of the project facilities like Bus Bay, Entry/Exit ramp and Junction Improvements have not yet been completed where the said gas pipeline has been proposed to be laid in the utility corridor of project highway.

After examining the case, our comments are as under : -

- i) It has been noted that the 125mm Dia MDPE Pipe in same trench through HDD method has been proposed to be laid in the Utility Corridor along the project highway from Km. 86.475 LHS to Km. 91.530 LHS (Length 5055m), Three crossing at Km. 89.165 (Length 77.10m), Km. 90.975 (Length 62.10m) & Km. 91.530 (Length 62.10m) and 110m Length Extra from Bus-Bay and Entry/Exit (Total Length 5366.30m) along NH-8 (New NH-48) (Delhi to Jaipur Road).
- ii) The depth of the 125mm Dia MDPE Pipe in same trench through HDD method has been proposed to be laid in the Utility Corridor along the project highway from Km. 86.475 LHS to Km. 91.530 LHS (Length 5055m), Three crossing at Km. 89.165 (Length 77.10m), Km. 90.975 (Length 62.10m) & Km. 91.530 (Length 62.10m) and 110m Length Extra from Bus-Bay and Entry/Exit (Total Length 5366.30m) along NH- 8 (New NH- 48) (Delhi to Jaipur Road) at minimum 1.65m below the Natural ground level.
- iii) There is three crossing at Km. 89.165, Km. 90.975 and 91.530 has been proposed for a depth of 1.65m below the Natural ground level.
- iv) The Service Road has already been constructed.
- v) The complete desired stretch of the submitted proposal are falling under the Rural section from Km. 86.475 LHS to Km. 91.530 LHS (Length 5055m), Three crossing at Km. 89.165 (Length 77.10m), Km. 90.975 (Length 62.10m) & Km. 91.530 (Length 62.10m) and 110m Length Extra from Bus- Bay and Entry/Exit (Total Length 5366.30m) along NH- 8 (New NH- 48) (Delhi to Jaipur Road) in Haryana section and the ROW in the Rural section is 62.10 m.

We have also worked out the license fee and performance bank guarantee in favour of NHAI which are required to be obtain from the applicant IGL, Rewari (Haryana) The amount for license for laying of 5366.30m Pipe Line along and across NH-8 section has been worked to 2,87,161-based on the prevailing circle rates for the particular area as made available by the applicant duly considering under the category of public utilities for this case as per the guidelines of MoRTH.

It is calculated at the rate of \$\mathbb{Z}\$100/- per route meter for pipe of size >=300 mm dia/width total length of 5366.30 m in NH-8 (New NH-48) for Rs.5,36,630/- on NH-8 (New NH-48) initially for a period of five years (extendable if required till satisfactory completion of work) as a security to comply with the requirements of conditions as per MORT&H circulars in this regard. The amount of the deposited for payment of Performance bank guarantee is Rs.5,36,630/- in this regard. The detailed calculation sheet for working the amount for License fee and performance bank guarantee is attached herewith.

Keeping in view of the aforesaid points and present status of works in the site, it is recommanded that permission for the laying of gas pipeline of Indraprastha Gas Limited may be accorded in favour of the Applicant except the facility locations mentioned above and the laying of gas pipeline in the balance locations can be carried out in the utility corridor portion

of project highway and after completion of said project facilities by the Concessionaire in the said facility locations.

Hence, we are submitting herewith duly signed and sealed copies of checklist & drawings along with Inspection Certificate as requested by the Authority for taking further action as deemed fit in this regard".

- 3. Accordingly, the proposal has been examine in this office and vide above referred letter dated 06.05.2021 has requested to M/s IGL, Rewari to submit the desired documents as per Ministry Circular dated 22.11.2016. M/s IGL ,Rewari vide above referred letter dated 28.08.2021 has submitted proof of deposition of License Fee of amounting of Rs. 2,87,161/-in Bharat Kosh vide Receipt No. 0608210011176 dated 06.08.2021 and Bank Guarantee No. 210127IBGP00858 dated 27.08.2021 of Rs. 5,36,630/- of IDBI Bank Ltd. valid upto 19.08.2022 for the Performance Security of the said proposal. Copy of BG confirmation is also enclosed. The license deed amount has been calculated duly considering DLC rate of agricultural land near national highway of respective village (copy of certified DLC rate and its calculation are also enclosed) and assumed it a public utility provider. M/s IGL has also submitted an additional undertaking for the said proposal vide their letter dated 28.08.2021 for any kind of additional license deed amount as when as it was demanded by NHAI/MoRTH within 07 days of receipt of notice.
- 4. In view of the above, the said proposal is seems to be found in order as per the prevailing site conditions. Duly signed checklist & drawings by undersigned is enclosed with the proposal and recommended to grant permission for laying and crossing of IGL Gas pipeline.

The proposal is forwarded for approval please.
