**Sub:** Four laning of Yavatmal - Wardha (Package-III) section of NH-361 from Km 400.575 to km 465.500 (Design Length -64.925) under NHDP Phase-IV on Hybrid Annuity Mode in the State of Maharashtra- **Permission for overhead and Underground 33 KV Electric Utility line from km 411+400 to km 414+300 (2.9 km) on Yavatmal - Wardha Road at village Bhari Tal. Dist. Yavatmal - Reg.**

It is to inform all concern that M/s Maharashtra State Electricity Distribution Company Ltd. letter under reference (2) has submitted a proposal for the subjected work and PD, NHAI, PIU, Yavatmal has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by the M/s Maharashtra State Electricity Distribution Company Ltd. is across Yavatmal - Wardha Section of NH-361 in the State of Maharashtra is as follows:

- Overhead line 33 KV Electric Utility line from km 411+400 to km 414+300 on NH-361.
- Crossing is proposed through HDD method from 412+220 to 412.300.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
