INVITATION OF PUBLICE COMMENTS

Subject: NHAI, Madurai Region - Highway Administration - Permission for laying of water Pipe line under PIU, Karaikudi - laying Water pipe line by TWAD Board, Project Division, Karaikudi 63mm dia HDPE pipe line along the road from Km. 94/400 to Km.95/900 (RHS); 140mm dia HDPE pipe along the road from Km.105/200 to Km.110/000 (RHS) by open trench method & across the road at Km.94/400; Km.96/000; Km.97/300; Km.106/700; Km.109/400 & Km.110/000 by trenchless method in Thirumayam - Manamadurai section of NH-226 in the state of Tamilnadu- Invitation of Public Comments - Reg.

The Proposal is regarding permission for laying of water supply pipeline from

- i. Along the road
 - i. 63mm dia HDPE pipe line from Km. 94/400 to Km.95/900 (RHS);
 - ii. 140mm dia HDPE pipe from Km.105/200 to Km.110/000 (RHS) by open trench method $\ensuremath{\alpha}$
- ii. Across the road at
 - i. Km.94/400;
 - ii. Km.96/000;
 - iii. Km.97/300;
 - iv. Km.106/700;
 - v. Km.109/400 & Km.110/000 by trenchless method in Thirumayam Manamadurai section of NH 226 TWAD Board, Karaikudi.
- 2) TWAD Board, Karaikudi has proposed to lay the Water supply pipeline for a length of 6495 m along the edge of the ROW, which is at a distance of 7.5m from centerline of the project and across the project at 06 location at a depth of 1.65m belong ground level. The proposal is in conformity with Ministry's guidelines vide letter No. NHIII/P/66/76 dated 19.11.1976.
- 3) Further TWAD Board, Karaikudi has mentioned that the Water supply pipeline along the NH by Open Trench Method at a depth of 1.15m for along portion and by HDD at a depth of 1.20m for across portion.
- 4) TWAD Board, Karaikudi has furnished an undertaking to the effect that the applicant will remove the laid Water supply pipeline in future if required by NHAI/MoRTH, Govt. of

India at any time for expansion of the NH at their own cost without claiming any compensation. Further, mentioned that TWAD Board, Karaikudi will also restore the surfaces to its original condition soon after removal of the Water supply pipelines.

5) As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/ S&R(R) dated 22.11.2016 the proposal submitted by the applicant will be made available for public comments and the comments is invited within 30 days from the day of uploading. In view of the above, comments of the public on the above proposal is invited to the below mentioned address:
