Sub.: Proposal for permission of erection/underground laying of 3*400 Sqmm. 33KV XLPE Cable along with 200mm OD HDPE pipe from Km. 30+250 (Line for New 33/11 KV S/S-Badalpur) to Km. 33+750 (RHS) & Km. 33+750 to Km. 36+100 (220 KV S/S NTPC, Dadri) (LHS) including 01 no. U/G road crossing at Km. 33+750 on NH-34 (Ghaziabad – Aligarh Section) in the State of Uttar Pradesh.

Senior Manager (WC-E&M-I), GNIDA, Greater Noida submitted the proposal for permission of erection/underground laying of 3*400 Sqmm. 33KV XLPE Cable along with 200mm OD HDPE pipe from Km. 30+250 (Line for New 33/11 KV S/S-Badalpur) to Km. 33+750 (RHS) & Km. 33+750 to Km. 36+100 (220 KV S/S NTPC, Dadri) (LHS) including 01 no. U/G road crossing at Km. 33+750 on NH-34 (Ghaziabad – Aligarh Section) in the State of Uttar Pradesh.

2. From the submitted proposal, it is observed that the proposed underground laying length is 5945m. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/ 2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
