INVITATION OF PUBLICE COMMENTS

Sub: NHAI, RO Madurai - PIU- Trichy - Padalur - Trichy section of NH 38 -TWAD Board providing water supply scheme to Koodapalli & 97 Habitations in Manachanallur and Musiri Union of Trichy District - laying of underground water Pipeline along the extreme edge of the NH 38 boundary from Km 300+900 (LHS) to Km 303+300 (LHS) and Km 300+670(RHS) to Km 301.100(RHS) and across Km 301+100 Invitation of Public Comments - Reg.

The Proposal is regarding permission for laying of water supply pipeline from

- a. Along the road by open trench method in the following chainages:
 - i. from Km 300+920(LHS) to Km 301+100(LHS) @ 90 mm Diameter HDPE pipe.
 - ii. from Km 301+100(LHS) to Km 303+300(LHS) @ 75 mm Diameter HDPE pipe.
 - iii. from Km300+670(RHS) to Km 301+100(RHS) @ 110 mm Diameter HDPE pipe.
- b. Across the road by HDD method in the following chainages:
 - i. Km 301+100(RHS) @ 110 mm Diameter Encasing pipe.

The laying of underground water pipeline has been proposed in section of NH-38 by Executive Engineer, TWAD Board, Urban Division, Trichy.

2) Executive Engineer, TWAD Board, Urban Division, Trichy has proposed to lay the Water supply pipeline for a length of 2810 m along the edge of the ROW, at a distance of 1.5m from ROW edge and across the project at a depth of 1.2m belong ground level.

Further, mentioned that Executive Engineer, TWAD Board, Urban Division, Trichy will also restore the surfaces to its original condition soon after removal of the Water supply pipelines
