Further, as the location appears to be in built area with lot of developmental activities and many cross roads, it may be preferred to lay the OFC through HDD method for the entire length & crossings.	as is id
3	1 no. crossing is shown between chainage 34.095 & 34.215. However, crossings is mentioned as at chainage 34.500. The drawings from 34.215 to 34.500 is not enclosed. This needs to be reconciled.	
4	Rate list issued by the competent authority in support of the rate considered in the license fee calculation needs to be submitted Rate list issued as per the prevailing rates of sub register market value of the respective circle is enclosed.	
5	The proposal in two sets along with License Agreement in original (two sets) as per the Ministry's guidelines dated: 22.11.2016 needs to be submitted along with the proposal. The agreement is to be made between "The Chief Engineer-Regional officer, MoRT&H, Bangalore" and M/s. Jio Digital Fibre Pvt., Ltd., leaving date/month/year as blank.
