Sub: Submission of proposal for permission to lay underground cable across km 22+800 of Saoner - Dhapewada road near Kalmeshwar underpass and also for overhead transmission line along the National Highway from km 22+240 to 22+800 i.e. 0.56 km length of RHS of Saoner Dhapewada section of NH-547E-Reg.

It is to inform all concern that M/s Shri Bhagirathi Textiles Ltd. letter under reference (2) has submitted a proposal for the subjected work and PD, NHAI, PIU-1, Nagpur has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s Shri Bhagirathi Textiles Ltd. is along Saoner - Dhapewada Section of NH-547E in the State of Maharashtra is as follows:

Laying of 33 KV Cable km from Ch. 22.240 to km Ch. 22.800 (total length 0.56 km) on NH-547E at edge of ROW

Crossing by HDD method of HT cable across at Ch. 22.800.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 28.01.2016 due to above transmission line on the subjected stretch.
