Proposal for grant of permission for laying underground PHED Pipeline dia 350mm DI K-7 along Sub.: NH from Mahabar Fanta to towards PWD NH Barmer (Chouhatan Choraha) on NH-68 (Barmer-Gandhav Bridge) from Km. 155+500 to 155+873 (0.373 km length) & crossing at Km. 155+873 (All Open Trench) under service road in the state of Rajasthan by PHED - reg.

It is to inform all concern that Ex. En. PHED Project Div II, Barmer vide letter under reference (i) above has submitted a proposal for the subjected work and PD, NHAI, PIU, Barmer has submitted the above proposal vide letter under reference (ii) for approval of the Competent Authority, Highway Administration.

The proposal is regarding grant of permission for laying underground PHED Pipeline dia 350mm DI K-7 along NH from Mahabar Fanta to towards PWD NH Barmer (Chouhatan Choraha) on NH-68 (Barmer-Gandhav Bridge) from Km. 155+500 to 155+873 (0.373 km length) & crossing at Km. 155+873 (All Open Trench) under service road in the state of Rajasthan by PHED.

- a. Estimate for Service road & main road repairing amounting to Rs. 3,45,316/(enclosed estimate).
- b. An amounting to Rs. 3,70,520/- for License fees/ lease rental charges for granting license for use to highway land shall be deposited by PHED before commenceing the work. Calculation sheet is attached for reference.
