It is to inform all concern XEN, DHBVN Rewari vide letter under reference (i) has submitted a proposal for the subjected work and PD, NHAI, PIU, Jaipur has submitted the above proposal vide letter under reference (ii) for approval of the Competent Authority, Highway Administration.

2. The proposal is regarding permission for laying electric cable (11 KV) along NH-08, road crossing at km. 68.500 at Dharuhera, Rewari in the state of Haryana.

Sir,

This has reference to XEN, DHBVN, Dharuhera above referred letter dated 20.07.2020 (Annex-1) regarding Permission for laying electric cable (11KV) along NH-08, road crossing at km.68.500 at Dharuhera, Rewari in the state of Haryana under Gurgaon-Kotputli-Jaipur section of NH-8.

2. The said proposal has been examined in Consultation with Independent Engineer of Gurgaon-Kotputli-Jaipur section of NH-8 M/s Aarvee Associates. Independent Engineer of the Gurgaon-Kotputli-Jaipur project vide their above referred letter dated 31.08.2020 (Annex-2) has informed to this office that:

" In this regard, NHAI, PIU, Jaipur has requested the IE vide letter 2nd cited to examine the checklist, drawings & other documents of the proposal as per site condition and strictly as per Ministry letter dated 22.11.2016 & letter dated 16.03.2017 & submit the clear cut recommendation along with Site Inspection Certificate to NHAI for taking further action.

In accordance with sub clause 43.1 of CA, the Concessionaire shall have right to the use of the site as sole licensee subject to and in accordance with the Concession Agreement, and to this end, it may regulate the entry and use of the Project Highways by third parties in accordance with and subject to the provisions of CA.

In view of the above, the Concessionaire was requested vide letter 1st cited to go through the contents of said proposal for laying of Electric Cable (11KV) along NH-08, road Crossing at km. 68.500 at Dharuhera, Rewari in the State of Haryana and inspect the site so as to examine whether the proposal is having any impact/hindrance to the construction, operation & maintenance work of NH-8 section and also to check that there is no damage to any of the structures of National Highway within the proposed ROW and submit your comments/inspection report with respect to Ministry of Road Transport & Highways Circular no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 & Ministry letter no.

RW/JAI/RJ/PS/2017/UTILITY/GENL/1161-1189 dated 16.03.2017 within three days along with the copy of the proposal for our review and comments.

It was also requested that comments on this matter shall clearly mention that whether the location of the proposed Electrical Cable crossing is in urban/rural area and other points which are not covered in Ministry Checklist but are necessary having regard to road safety.

The Concessionaire's Consent/no objection for the said proposal has not been received till date from the date of IE's letter no. 9603 dated 22.08.2020 to Concessionaire under reference 1st cited. As more than days have elapsed since our request to the Concessionaire, it is informed that the consent of the Concessionaire is deemed to have been received for this case and it is also presumed that there is no objection from the Concessionaire.

However, we had gone through the contents of said proposal and carried out detailed site inspection and also examined the checklist, drawings & other documents of the proposal as per site condition. Our comments on this proposal are also given below.

Upon examination of the drawings, it was noted that, the applicant had proposed for crossing of Electrical line at km. 68+500 on NH-8.

The IE has inspected the proposed site on 25.08.2020 along with applicant M/s DHBVN, Dharuhera, Rewari representative; Upon verification of the proposed location for crossing of Electrical line in the site, it has been found that the corrected location of the proposed for crossing of Electrical line at km. 68+500.

The proposal for crossing the project highway at km. 68+500 has been examined by the IE and the same has been found to meet all the criteria necessary for according the permission and they are found to be in order.

After examining the case, our comments are as under:-

- (i) There is only one crossing at km. 68+500 for a length of 53.6 m in urban location of the project highway and depth of the Electrical line to be laid is minimum 3 meter below the Natural ground level.*
- (ii) There is one LHS Bus Bay km. 67+825 & one is RHS km. 68+053.*
- (iii) There is no Truck Lay Bye facility at the proposed location.*
- (iv) There is one Loop type Entry / Exit at km. 66+110 from the proposed crossing of electrical line at km. 68+500.*
- (v) The Service road has already been completed.*
- (vi) There is one flyover at km 71+002 which is already opened to traffic.*

We have also worked out the license fee and performance bank guarantee in favour of NHAI which are required to be obtained from XEN Construction division, DHBVN, Rewari. The amount for license for laying of 52.60 m along NH-8 section has been worked to Rs. 7,206/- based on the prevailing circle rates for the particular villages as made available by the applicant duly considering under the category of public utilities for this case as per the guidelines of MORTH under reference 4th cited. The amount for performance bank guarantee has also been worked out. It is calculated at the rate of Rs. 250/- per route meter for OFC of size > 300 mm dia/width but <=1000 mm for total length of 52.60 m along the NH-8 for Rs. 13,150/- on NH-8 initially for a period of five years (extendable if required till satisfactory completion of work) as a security to comply with the requirements of conditions as per

MORT&H circulars in this regard. The amount to be deposited for payment of Performance bank guarantee is Rs. 13,150/- in this regard. The detailed calculation sheets for working the amount for License fee and performance bank guarantee is attached herewith. In view of the above, the IE recommends for permission to be accorded for laying the said Electrical line in favour of the Applicant”.

3. The proposal was examined in this office and vide above referred letter dated 16.09.2020 **(Annex-3)** has sought some more clarifications & documents from XEN, DHBVN.
4. XEN, DHBVN vide above referred letter dated 18.09.2020 **(Annex-4)** has submitted proof of deposition of License Fee of amounting of Rs. 7,206/- in Bharat Kosh vide Receipt No. 1809200002392 dated 18.09.2020 and Demand Draft no. 003267 dated 16.09.2020 of Rs. 13,150/- of IDBI Bank for the Performance Security of the said proposal. The license deed amount has been calculated duly considering DLC rate of agricultural land near national highway of respective village (copy of certified DLC rate and its calculation are also enclosed) and assumed it a public utility provider. DHBVN, has also submitted an additional undertaking for the said proposal vide their letter dated 18.09.2020 for any kind of additional license deed amount as when as it was demanded by NHAI/MoRTH within 07 days of receipt of notice.
5. Further, while scrutiny of the proposal, it is noted that IE has calculated the amount of BG and License fee for a length of 52.06 mtr in place of 53.06 i.e. as per check list or ground condition. Hence, this office vide above letter dated 08.10.2020 **(Annex-5)** has demand the additional fees as per MoRTH Circular dated 22.11.2016. XEN, DHBVN vide above referred letter dated 14.10.2020 **(Annex-6)** has submitted proof of deposition of additional License Fee of amounting of Rs. 138/- in Bharat Kosh vide Receipt No. 1410200003762 dated 14.10.2020 and Demand Draft no. 785992 dated 14.10.2020 of Rs. 250/- of Canara Bank for the Performance Security of the said proposal.
6. Hence, the said proposal has been verified and is seems to be found in order as per the prevailing site conditions. Duly signed checklist & drawings by undersigned is enclosed with the proposal.
7. In view of the above, permission for laying DHBVN electric cable (11KV) along NH-08, road crossing at km.68.500 at Dharuhera, Rewari in the state of Haryana may be granted.

The proposal is forwarded for further necessary action please.







We refer to the letters cited regarding the above mentioned subject, wherein NHAI had stated that the Office of the DHBNV, Dharuhera vide letter dated 20.07.2020 had submitted the said proposal for laying of Electric Cable (11KV) along NH-08, road Crossing at km. 68.500 at Dharuhera, Rewari in the State of Haryana for examining the said proposal in accordance with Ministry's Guidelines issued vide letter no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 & Ministry letter no. RW/JAI/RJ/PS/2017/UTILITY/GENL/1161-1189 dated 16.03.2017.

In this regard, NHAI, PIU, Jaipur has requested the IE vide letter 2nd cited to examine the checklist, drawings & other documents of the proposal as per site condition and strictly as per Ministry letter dated 22.11.2016 & letter dated 16.03.2017 & submit the clear cut recommendation along with Site Inspection Certificate to NHAI for taking further action.

In accordance with sub clause 43.1 of CA, the Concessionaire shall have right to the use of the site as sole licensee subject to and in accordance with the Concession

SP

Agreement, and to this end, it may regulate the entry and use of the Project Highways by third parties in accordance with and subject to the provisions of CA.

In view of the above, the Concessionaire was requested vide letter 1st cited to go through the contents of said proposal for laying of Electric Cable (11KV) along NH-08, road Crossing at km. 68.500 at Dharuhera, Rewari in the State of Haryana and inspect the site so as to examine whether the proposal is having any impact/hindrance to the construction, operation & maintenance work of NH-8 section and also to check that there is no damage to any of the structures of National Highway within the proposed ROW and submit your comments/inspection report with respect to Ministry of Road Transport & Highways Circular no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 & Ministry letter no. RW/JAI/RJ/PS/2017/UTILITY/GENL/1161-1189 dated 16.03.2017 within three days along with the copy of the proposal for our review and comments.

It was also requested that comments on this matter shall clearly mention that whether the location of the proposed Electrical Cable crossing is in urban/rural area and other points which are not covered in Ministry Checklist but are necessary having regard to road safety.

The Concessionaire's Consent/no objection for the said proposal has not been received till date from the date of IE's letter no. 9603 dated 22.08.2020 to Concessionaire under reference 1st cited . As more than days have elapsed since our request to the Concessionaire, it is informed that the consent of the Concessionaire is deemed to have been received for this case and it is also presumed that there is no objection from the Concessionaire.

However, we had gone through the contents of said proposal and carried out detailed site inspection and also examined the checklist, drawings & other documents of the proposal as per site condition. Our comments on this proposal are also given below.

Upon examination of the drawings, it was noted that, the applicant had proposed for crossing of Electrical line at km. 68+500 on NH-8.

The IE has inspected the proposed site on 25.08.2020 along with applicant M/s DHBVN, Dharuhera, Rewari representative; Upon verification of the proposed location for crossing of Electrical line in the site, it has been found that the corrected location of the proposed for crossing of Electrical line at km. 68+500.

The proposal for crossing the project highway at km. 68+500 has been examined by the IE and the same has been found to meet all the criteria necessary for according the permission and they are found to be in order.

After examining the case, our comments are as under:-



- There is only one crossing at km. 68+500 for a length of 53.6 m in urban location of the project highway and depth of the Electrical line to be laid is minimum 3 meter below the Natural ground level.
- There is one LHS Bus Bay km. 67+825 & one is RHS km. 68+053.
- There is no Truck Lay Bye facility at the proposed location.
- There is one Loop type Entry / Exit at km. 66+110 from the proposed crossing of electrical line at km. 68+500.
- The Service road has already been completed.
- There is one flyover at km 71+002 which is already opened to traffic.


In view of the above, the IE recommends for permission to be accorded for laying the said Electrical line in favour of the Applicant.






