It is to inform all concern that M/s Telesonic Networks Ltd. (Airtel) vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Amravati has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by M/s Telesonic Networks Ltd. (Airtel) is from LHS Nagpur Akola Road Chainage km 155.000 to km 155 500 total length 0.500 kms. Crossing at Chainage km 155.000 on Talegaon –Amravati along the NH-53 in the State of Maharashtra. The following activity is involved:
 - Underground Optical Fiber Cable to be laid in duct in utility corridor from km. 155.000 to km 155.500 (LHS).
 - Crossing by HDD method at Ch. km. 155.000
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
