It is to inform all concern that M/s Telesonic Networks Ltd. (Airtel) vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Amravati has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by M/s Telesonic Networks Ltd. (Airtel) is from RHS on Chhattisgarh / Maharashtra border - Wainganga Bridge Chainage km 485.000 to km 480.000 total length 5 kms. Crossing at Chainage km 155.000 on Talegaon -Amravati along the NH-53 in the State of Maharashtra. The following activity is involved:


- Underground Optical Fiber Cable to be laid in duct in utility corridor from km. 485.000 to km 480.000.
