2. The alignment proposed by that the M/s. Unison Enviro Private Limited, Latur across Tuljapur- Ausa Section of NH-361 in the State of Maharashtra is as follows:

- 8" NB underground Carbon Steel Natural Gas Pipeline along with two (2) Nos. 40mm OD HDPE OFC Duct on NH from Km.33.820 to Km.55.835
- Crossing at Km.33.820 near Ashiv village road-SH-23 Intersection through HDD method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
