SUB: Four laning of Ahmedabad to Godhra Section of NH-47 from Km. 4.200 to 122.420 in the State of Gujarat on DBFOT Basis under NHDP Phase III.

- Proposal seeking ROW permission for **Overhead Crossing** of 66KV D/C LILO line to 220KV Sevaliya S/S from existing 66KV Malitadi-Jorapura Transmission Line across Ahmedabad-Indore NH-47 b/n Km 75+000 and Km 76+000 in the state of Gujarat.


