- The proposal is regarding permission for laying 16" Dia Multi Product Pipeline Along 1. NH-544H from BPCL Irugur Terminal Coimbatore to Devangonthi Terminal, Bangalore, along NH-544H from Ch.5/030 km to 15/805 km (RHS) for a length of 10.775 km and Across NH-544H @ Ch. 15/805 km (RHS-LHS) for a length of 30m by Open cut and HDD method by M/s. Bharat Petroleum Corporation Limited, on Thoppur -Mecheri section of NH-544H.
- M/s.
