It is to inform all concern that M/s MSEDCL, letter under reference (2) has submitted a proposal for the subjected work and PD, PIU Washim has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s MSEDCL is across Washim-Pangare Pkg-III & Pangare-Waranga Phata Pkg-IV section of NH-161 in the State of Maharashtra is as follows:

- 11KV Underground crossing at Km. 97.300, km 107.100, km 133.200, km 143.500 & km 143.500.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
